

Dealertrack California Reg & Title | AB 516 READINESS:

TEMP TAG PAPER INVENTORY & ORDERING

AB 516 requires that dealers print temporary tags on specialty paper. To ensure that your dealership is ready to print Temp Tags via the California Reg & Title (“California Online Registration System”, “CA-OLRS”) solution, you must order your specialty paper inventory no later than **Friday, November 30, 2018**.

This is a time-sensitive request, and your immediate attention is required. Failure to complete this step may result in your inability to process temporary tags.

Temporary tag paper will be available to order on the Order Inventory page in the CA Reg & Title application. There will be two sizes of the paper available - one size that’s designed to fit on a normal auto/truck vehicle type (6”x11”) and one size that’s designed to fit on a motorcycle (4”x7”). Both sizes of paper will arrive on a standard 8.5”x11” sheet so they can be fed into the printer without issue; however, perforations and holes will be in different locations based on the TLP paper size. Once the tag is printed, you’ll be able to easily tear off the unnecessary sections of the paper and use the pre-punched holes to affix the temporary tag to the vehicle.

There will be a cost associated with the temporary tag paper and fulfillment of the paper, and these costs will be charged via your existing Automated Clearing House (ACH) account upon fulfillment of your order. The charges for temporary tag paper will be as follows:

Please note: All prices are inclusive of actual temporary tag paper and fulfillment.

As a reminder, the document processing charge will be increased by \$5.00 to help offset the additional costs that will be incurred by dealers. For BPA participants, the document processing charge will be raised from \$80.00 to \$85.00. For non-BPA participants, this charge will increase from \$65.00 to \$70.00.

Inventory FAQs:

Q: How will I obtain this special temporary license plate paper?

A: You will be able to order the required paper through the Order Inventory page in the California Reg & Title solution. The temporary tag paper will be available under the MISC section on this page:

NOTE: If ordering TLP paper, you will be charged when your order is filled.

Q: What's the difference between "TLP Paper – Auto & Truck" and "TLP Paper – Motorcycle"?

A: The temporary license plate paper will be available in two sizes – one size that's designed to fit on a normal auto/truck vehicle type (6"x11") and one size that's designed to fit on a motorcycle (4"x7"). Both sizes will arrive on a standard 8.5"x11" sheet so they can be fed into the printer without issue; however, perforations and holes will be in different locations based on the TLP paper size. Once printed, you'll be able to easily tear off the unnecessary sections of the paper and use the pre-punched holes to affix the temporary tag to the vehicle.

Q: What vehicles will require temporary license plates?

A: Any new or used vehicles sold that do not already display license plates. This includes passenger vehicles, trucks, motorcycles, trailers, and motorhomes. Based on the vehicle type, either 1 or 2 temporary license plates will be required. For example, if the vehicle is a passenger vehicle, truck, or motorhome, 2 temporary license plates will be required. If the vehicle type is camp trailer, trailer coach, trailer, motorcycle, or electronic motorcycle, only 1 temporary license plate will be required.

Q: How much paper should I order?

A: Most vehicle types will require 2 sheets of paper per vehicle sold, as DMV requires that a temp tag be affixed to both the front and rear of the vehicle. This applies to all passenger vehicles, trucks, and motorhomes. Only 1 sheet of paper will be required for each trailer or motorcycle sold. To determine the appropriate quantity of paper you should order, please refer to your expected volume and types of vehicles that will be sold during the period for which you'd like to have paper on-hand. You may also want to include some extra, in the case that a temporary tag needs to be reprinted.

For example, if you typically sell 100 passenger vehicles in 1 month, and you'd like to have a 1-month supply of temp tag paper on hand, your order should contain at least 2 packs of TLP-Auto paper (each pack contains 100 sheets, and you'll need 200 sheets for this period).

Q: What if my printer jams when I'm printing the temporary license plate?

A: You will be able to reprint a temporary license plate up to 2 times, as needed, for scenarios such as a paper jam. If additional reprints are required beyond 2, manager approval will be needed.

Q: Will I need to affix two temporary license plates to the vehicle?

A: Yes, if the vehicle type is a passenger vehicle, truck, or motorhome, 2 temporary license plates will need to be printed and affixed to the vehicle. If the vehicle type is a trailer, camp trailer, trailer coach, motorcycle, or electric motorcycle, only 1 temporary license plate will need to be printed and affixed to the vehicle.

Q: What's the cost of the temporary license plate paper?

A: The temporary license plate paper will be sold in packs of 100 sheets (for the Auto/Truck-sized paper) and packs of 20 sheets (for the Motorcycle-sized paper). The cost will be per pack of paper, \$70 for pack of 100 Auto-sized sheets and \$30 per pack of 20 Motorcycle-sized sheets.
